This is a HUGE program and WE NEED YOUR HELP!!!! Since many of our parents have volunteered to assist the program during the duration of our dance seasons in the past, we would like to give you the opportunity to let us know specifically in what areas you would like to help.

- ○ **“STAGE MOM”** Our dancers do not sit in a room but in the auditorium to watch the recital. There are chaperones called “Stage Moms” assigned to each GROUP to assist with overall behavior as well as “bathroom runs”. You would sit with your dancer’s GROUP during the entire recital, take them to the stage to perform, help with costume changes, and take the group back to their seats. There will be a “STAGE MOM” meeting held in May to explain exactly what you need to do and answer any questions. You will also be given your backstage pass at the meeting to be backstage since the only parents allowed backstage are stage moms.
 - ○ **COSTUMES** (*sewing by hand or machine*) This may involve minor sewing/adjusting and/or adding trim to pre-purchased costumes. Also can involve making headpieces for costumes, etc. Miss Val will discuss any costume needs with you prior to assigning. Please check: _____ by hand _____ by machine _____ either
 - ○ **PROPS/SCENERY** Some are handmade, some are bought and we reimburse you. These are items used by the dancers in the routines to enhance our recital productions like drumsticks, flower bouquets, briefcases, flower hoops, decorated baskets, etc. Creative minds are always welcome.
 - ○ **SET-UP FOR RECITAL** We set-up on the Friday evening before dress rehearsal. This involves hanging props, taping wires, decorating the stage, setting up the dressing rooms and auditorium, etc.
 - ○ **ADVANCE RECITAL PREPARATION** Work with administrative aspects of the recital that require weeks or months of lead-time. These include the 50/50 raffle, patron ads, and recital program preparation.
 - ○ **BACKSTAGE HELP** This involves preparing dancers prior to going on stage. Your help would be needed in either recital. **YOU WOULD MISS THE RECITAL BUT NOT MISS YOUR DANCER’S NUMBER.**
 - ○ **FLYER PRINTING** Can you print or copy pages at no cost to the LTRC Tap/Jazz Program? To reduce costs we need help printing copies of flyers --- usually 1 to 5 pages each, for each of our 300 dancers.
 - ○ **RECITAL PROGRAM PRINTING** Can you print or copy two-sided pages at no cost to the Tap/Jazz program? To reduce program costs, we need help in printing the pages of our recital programs. We run anywhere from 300 to 1000 copies of each two-sided page. The program with patrons and ads can be up to 50 pages. We are looking for people who can print portions of our program booklet for free. Anything will help.
